## ORDER GRANTING EX PARTE EMERGENCY RESTRAINING ORDER

NOW on this 5th day of August, 2022 this matter comes before the undersigned Special Associate Judge upon Plaintiff's Ex Parte Application for Emergency Restraining Order. The Court having considered the application and the corresponding exhibits, does hereby FIND and ORDER as follows:

- 1. That the Defendant Ben Karnes has repeatedly acted contemptuously with regard to this Court's Orders by publicly holding himself out to be an elected official of the Modoc Nation.
- 2. That Defendant Karnes has expressed public remarks that are contrary to the peace and welfare of the Modoc tribal members and is now alleged to have publicly used social media and or other electronic means to encourage individuals, Modoc members and non-Members to enter tribal lands during the Annual Meeting at the Modoc Nation Tribal Council on May 6, 2022 for the purpose of protesting or otherwise causing chaos or controversy.
- 3. That Plaintiffs have demonstrated facts sufficient for the entry of this Ex Parte Emergency Order enjoining the Defendant and any persons acting in concert with him from engaging in any behavior that is contrary to the peace and welfare of the Modoc Nation,

specifically to prevent the Defendant from engaging in any behavior intended to disrupt the Annual Meeting of the Modoc Nation, scheduled for August 6, 2022.

- 4. That the Defendant is hereby enjoined from acting in any manner to coerce or encourage individuals from attending the Annual Meeting of the Tribal Council of the Modoc Nation for the purpose of causing a disruption to the proceedings.
- 5. That the Defendant, Ben Karnes, is further restrained from engaging in any behavior at the Annual Meeting, including but not limited to protesting, demonstrating or other behavior intended to create a division, chaos or controversy during the August 6, 2022 Annual Meeting.
- 6. That any behavior by the Defendant or other individuals acting in concert with the Defendant or at his request or encouragement to disrupt the Annual Meeting of the Modoc Nation will result in his immediate removal by law enforcement as well as further proceedings of trespass.
- 7. That individuals who are not Modoc Nation members with notice of this Order and who are acting in concert or participation with Defendant Ben Karnes shall not not enter tribal lands during the Annual Meeting of the Modoc Nation Tribal Council on August 6, 2022, or otherwise engage in any activity intended to disrupt the Annual Meeting of the Modoc Nation Tribal Council on August 6, 2022.

For purposes of this Order, a non-member of the Modoc Nation shall mean any person, other than Kirk Miller, Kirk Miller's legal counsel, and legal counsel for the Modoc Nation, whose name is not on the list of "all the individuals 18 and over as of August 4, 2022, who meet all the requirements in the Constitution of the Modoc Nation, as amended in 2020, who are duly recognized as members of the Modoc Nation," published on the Modoc Nation's official website, <a href="https://modocnation.com/news/">https://modocnation.com/news/</a> as of this date, and attached hereto.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Defendant, Ben Karnes, and any other individuals acting in concert with Defendant Karnes, is hereby RESTRAINED from encouraging or coercing any individuals from entering upon the lands of the Modoc Nation with the intent to disrupt or cause chaos during the Modoc Nation Annual Meeting, scheduled for August 6, 2022.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Defendant Ben Karnes is specifically RESTRAINED from entering upon the tribal lands of the Modoc Nation with the purpose of acting in a manner that is disruptive and intended to cause chaos or controversy during the Annual Meeting of the Modoc Nation.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Court ORDERS that individuals who are not Modoc Nation members with notice of this Order and who are acting in concert or participation with Defendant Ben Karnes shall not not enter tribal lands during the Annual Meeting of the Modoc Nation Tribal Council on August 6, 2022, or otherwise engage in any activity intended to disrupt the Annual Meeting of the Modoc Nation Tribal Council on August 6, 2022.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Court shall have a show cause hearing on this matter on August 8, 2022 at 10:00 a.m.

IT IS SO ORDERED.
