#### INSTRUCTIONS FOR ENROLLMENT APPLICATION MODOC NATION

- 1. Application must be filled out completely. If a question does not apply to you, write not applicable. If you do not know the answer to a question, state unknown or I do not know. Do not leave any questions blank unless instructed to do so.
- 2. You must provide the following items with the completed application
  - a. Original Birth Certificate (a copy is not sufficient). If the parent who is enrolled with the Modoc Nation is not listed on the birth certificate, a certified copy of a Court Order establishing paternity will need to be submitted and genetic test results, if genetic testing was performed.
  - b. A copy of the Applicant's social security card.
  - c. A copy of the Applicant's Driver's License or State ID if the applicant is 16 years of age or older.
  - d. If the applicant is adopted or had a name change, a certified copy of the court order will also need to be provided. If the applicant's married name is different than the name on the birth certificate, a copy of the marriage license will need to be provided.
  - e. A birth certificate or death certificate of each ancestor tracing lineage back to the Modoc Allotee on the 1878 Base Roll will need to be provided.
  - f. Any documents that have been amended are subject to investigation by the Tribal Registrar at any time.
- 3. For full name of Applicant, write the first, middle and last names of the applicant.
- 4. For Indian, Maiden or other Names, state all additional names that the applicant could be identified by.
- 5. State the complete physical (911 responder) address of the applicant.
- 6. State the mailing address if it is different from the physical address, otherwise applicant may write same for all blanks.
- 7. State the date of birth of the applicant, in the following format: XX/XX/XXXX. For example: 01/01/2012.
- 8. Check whether the applicant is male or female. Mark only one box.
- 9. State the full social security number for the applicant.
- 10. State the Place of birth, including City, County, and State.
- 11. State a telephone number where the applicant can be reached.
- 12. State an e-mail address for the applicant, if any. If no e-mail address exists, write not applicable or none.
- 13. State the name of the Modoc Allottee on the 1878 Base Roll which the applicant claims as their ancestor. If the ancestor's name is unknown, state unknown.
- 14. State the allottee number of the ancestor on the 1878 Base roll, if unknown, state unknown.
- 15. Check yes or no as to whether applicant possesses Indian Blood of another Tribe(s).
- 16. If applicant marked no, skip questions #4-8 and instructions #17-21.
- 17. If applicant marked yes, answer questions #4-8.
- 18. Check yes or no as to whether applicant is an enrolled member of another Tribe.
- 19. Provide the name of the Tribe of which applicant is an enrolled member.
- 20. Check yes or no as to whether applicant has ever been an enrolled member of a Tribe and state what Tribe and when applicant was an enrolled member.
- 21. Check yes or no if applicant received benefits in land or money by virtue of being an enrolled member now or previously with a Tribe.
- 22. State the date the application is signed.
- 23. Print the name of the signer.
- 24. If applicant is 18 years of age or older, applicant must sign the enrollment application unless the applicant has a guardian.
- 25. If applicant is less than 18 years of age or older or a court order establishing a guardian/custodian of the person is in effect, the parent or guardian may sign the applicant. A certified copy of the court order must accompany the application if the person signing the application is not the applicant or a biological parent.
